
If Ataxia Specialist Nurses are the answer.... What's the problem?

- 49% 12+ months after GP visit to be seen by a neurologist (NNPE)
- 42% additional 12 months to be diagnosed. (NNPE)
- 44% lack of emotional support. (AUK2020)
- 43% lack of information about ataxia and symptoms (AUK2021)
- 38% lack of practical support (AUK2020)
- 28% completely understood the explanation of their diagnosis given at diagnosis (NNPE)
- 74% felt lack of knowledge from GPs and other primary care professionals. (AUK2021)
- 35% felt lack of knowledge from consultants or neurologists (AUK2020)
- 68% not asked about mental wellbeing by a health or social care professional (NNPE).
- 28% had access to speech therapy which met most needs. (AUK2020)










What can Specialist Nurses Bring?

- Knowledge of, and insight into, the patient pathway/services available
- High-level expertise in the care of a specific patient group.
- Additional qualifications meaning they can perform advanced tasks
- Considerable knowledge of the organisation in which they work, and of partner organisations







Aim: To improve the quality of life of people affected by ataxia.

- Improve access to treatment and care
- Faster diagnosis
- Individual support
- Information, advice and support to enable informed decisions about the future; access entitlements; and exercise rights.
- Reduce mental health consequences of ataxia





Impact: people will be able to...

- Access appropriate care including therapies mitigating the physical impact of their condition.
- Increase their incomes/reducing the impact of income loss by claiming their benefit entitlements, and dealing with money and debt issues.
- Plan financially for the future.
- Deal with housing issues and make appropriate housing choices.
- Deal with employment issues, including around hours, retirement and reasonable adjustments.





Aim: To improve the quality of care the NHS can provide to people affected by ataxia.

- Information, advice and training to clinicians and therapists to raise their awareness, interest, and understanding of ataxia.
- Improved networking between clinicians and therapists, and ataxia expert clinicians and therapists – creating a Hub and Spoke Model
- Development of further ataxia clinics
- Swift adoption of proven treatments when available.
